PUBLICATION

All the lectures (6-8 pages) will be reviewed and published in the Conference Proceedings in electronic form with ISBN and DOI numbers. All conference participants are eligible to compete for the Best Paper Awards by submitting a full paper.

After the Conference, the extended and revised versions of those papers, which will be selected, by the Scientific Committee and the reviewers will be published in two monographs (one in Hungarian, one in English language) or in different Hungarian and international scientific journals. (The minimum size of the monograph and journal papers should be 30,000-40,000 characters (12-15 pages). Journal publications should be prepared according to the journal requirements.)
